



## A Big Heart for Casa

Casa Youth Shelter didn't even exist when its number one fan, Kenny Brandyberry, first started helping kids. Just 18 years old and an assistant manager at a Smart & Final in Los Angeles, Kenny recalls the day a man came in looking for a sponsor for one of his Little League baseball teams. Kenny recalls, "He had five teams and a deadline and I said, 'Give me all five!' I knew I had a winner, right? I had the first-, second-, third-, fourth- and fifth-place teams!" The sponsorship came out of his own pocket, because Kenny knew first-

hand what sports could mean for kids who had little money.

As a boy living in Bell, a modest community about 20 miles north of Los Alamitos, Kenny

cut lawns and collected bottles to raise his own funds to buy a bat and glove to play ball. His playing continued from Little League through his Air Force days. Not surprising to those who know him, he was a pitcher then and he never tires of pitching today. Even in his Smart & Final days,

Kenny was gregarious and engaging, and customers would line up and wait for him to serve them, saying, "We'll wait for the kid." He came to the Los Alamitos/ Cypress area, and leveraged his outgoing personality by tending bar at a place called Gopher City. Later, as owner of the Red Rooster in Cypress, where he sold beer for 25-cents a glass, he sponsored the Continental Little League. Because the name of a bar on the players' shirts wasn't appropriate, his teams were simply called "Ken's."

### A modest beginning

Kenny eventually opened the Starting Gate in Los Alamitos, and was a local business success for 27 of his 43 years in the bar business. One of the Starting Gate's first promotions was a chili cook-off, and with its modest proceeds, he looked for a nearby charity to contribute to.

"Casa Youth Shelter was close by," Kenny says, "so I walked over there and met Luciann and gave

her the \$300. You'd have thought I gave her three-million! She was so appreciative, it was absolutely unreal. They showed me through the house – and meeting sweet Myldred was the icing on the cake. I knew right there what charity I'll always be involved in."

### Sixteen summers

Always helping the kids, Kenny just finished his 16th Annual Party-of-the-Year fund raiser. With some 200 of his closest friends, his backyard miniature golf tournament raised \$56,000! The one-day event, always the Sunday after Father's Day, takes an entire year of preparation, and he spares no expense with abundant food and an open bar. The proceeds come from the admission tickets, raffle items and silent auction treasures. And the event expenses? Kenny covers them himself. Every penny collected for the party goes to Casa's kids. With this year's results, his total donation over the 16 years now exceeds a half-million dollars! Having good friends who sponsor high ticket opportunity drawings helps, too. His passion for the cause has captivated Danny Rayburn, Dapper Charlie Slaymaker and Alex Varonos who have taken up the

banner and contributed \$1,000 in gasoline, \$1,000 of groceries, and an all-expenses-included Hawaiian vacation.

### The pizzas delivered

This year, good friends Alex and Lee of Valentino's Pizza in Los Alamitos did something extraordinary. As a kick-off to

Kenny's big party, Valentino's offered an extra-large, two-topping pizza for just \$10.00 every Monday in

# On Board with Scott Rifkin



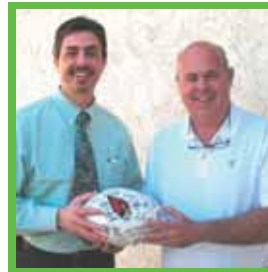

# Case Study

## Timmy and his "Family"

Timmy, a made-up name to protect his and his family's confidentiality, is a 12 year-old who was born and raised in Mexico until age 6. His mother and father were drug addicts, and both suffered from mental illnesses. His father committed suicide and his mother just wasn't there for him or his brother, ever. From about age two, he alternated between his aunt's home and his mother's. Then at about age six, he came to live with his great-aunt who had recently married and moved to California. He calls his great-aunt "mom" and his new step-father "dad."

He was brought to Casa Youth Shelter due to his acting out at home, throwing temper tantrums, not following direction, performing poorly in school and excessive arguing with mom. The parents desperately needed a cooling off break.

At Intake Timmy presented younger than his years, possible as young as age 8. His counselors speculate that possibly he was born as a drug-baby or that he may be mildly developmentally delayed. Timmy appears to have the words to describe his behavior but does not appear to understand what the words truly mean.

### In Good Hands

In the week that Timmy was with us his counselors met with him for individual counseling four times and for family counseling sessions three times. He also attended group counseling and educational classes for a total of 21 hours.

Our goals for Timmy and his family include continued family counseling sessions to help in the role-development of the step-father in Timmy's life, to help in the blending of the two families and their values. The family has started T.O.P.S. Parenting Classes to help them in learning how to develop clear and concise rules and how to consistently enforce them. Timmy is also being referred to a psychologist and psychiatrist to fully assess any physical disabilities that he may have.

Our prognosis for this family is good. They appear to be highly motivated to want to make a difference in their lives, especially for Timmy and his brother. We feel privileged to be able to help this family in crises.

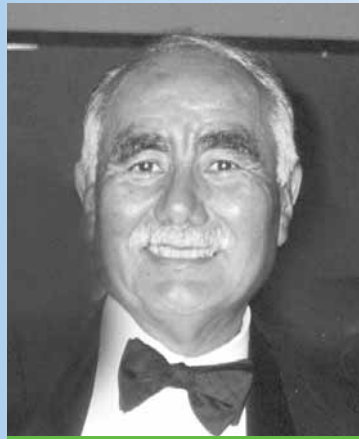

# In Memory of General Dan: A Soldier's Soldier

Much is known about General Hernandez's long and distinguished military career – his private volunteer contributions as an active member of the CA Military Academy Alumni Association and the Long Beach Chapter of the American Red Cross Board of Directors – but maybe less is known about his personal devotion to Casa Youth Shelter. As an honored and long-standing member of Casa's Board of Directors, General Dan was not only an effective and supportive director; he was a cherished friend and caring mentor for the Casa Kids.

There were always a few older boys who would benefit from an introduction to General Dan. These boys lacked positive, successful male role models in their lives, and many had had

minor run-ins with the law: Struggling to fit in, they didn't know how. General Dan uniquely understood. He had a way of positively influencing these boys whose lives were in desperate need of an honorable man's influence, and he made the time to do so.

General Dan was always available. Whether in his "boots on the ground" army fatigues or full-dress uniform

complete with stars and campaign ribbons, he was an imposing sight. He would meet with the boys, encourage them to put their pasts behind them and persevere in building better lives as he provided helpful guidelines. He often recommended the military as a great starting point for turning their lives around. And he didn't forget them after they left Casa: He reminded them they had a friend.

# Casa Program Services

Casa Youth Shelter's primary service is offering emergency shelter to youth at risk or who have become runaways or homeless. Our goal is to reunify them with their families safely.

Generally a youth does not attend school while with us. If their lives are in such crisis that they need to be out of their homes, they will not do well in an educational environment. Instead, we have their parents bring us study packets from school, which they work on daily.

Since we have the youth with us 24/7, we fill up their time with productive activities, including:

**Individual Counseling** – 2 to 3 times per week to help the child work on their feelings associated with being forced from their home and to develop exit goals.

**Family Counseling** – 2 times per week to develop a dialog between the youth and their parents during their cooling off period while the child is at the shelter.

**Group Counseling and Psycho-Educational Classes** – 2 to 3 times per day for survival skills. Topics addressed include: Anger Management/Assertion Training, Art Therapy, Decision Making, Self-Esteem, Substance Abuse and Pet Therapy.

**Recreation** – every day at our new Sports Court as well as our large recreation room and offsite outings.
